The Club

The Cockburn Power Boats Association was founded in 1961 at Clarence Rock in Henderson and was incorporated in 1963.

The Club relocated to its current site in 1981.

The Club is located in the Department of Transport's Woodman Point Recreational Boating Precinct which is the busiest launching ramp location south of the Swan River. The Club is a not for profit organization with our core objective the promotion and encouragement of the use of recreational water craft powered by sail or engine and the exchange of knowledge to ensure members understanding and compliance with the regulations and laws applicable to recreational boating and safety at sea.

Social Events and Activity Groups

CPBA offers a variety of activities. Members and their families are welcome to participate in any or all of the following:

- **Sportfishing Group** - Conduct monthly fishing competitions, group fishing trips and information nights.
- **Cruising Group** - This group hold family oriented boat outings, convoys, overnight stays and offers members the opportunity to socialise on planned outings. Head out in company to such destinations as Mandurah, Garden Island, and Fremantle with the purpose of having fun and the odd time trialling.
- **Social** - The Club calendar includes social activities throughout the year including Sundowners, Quiz Nights, New Years Eve and live entertainment including a monthly Sunday Session.

CPBA clubhouse boasts superb panoramic views of Cockburn Sound and is a great venue for socialising. Drop down for a quiet drink on the weekend and bring family and friends along.

Private Functions - The fully licenced Clubhouse has rooms available for Members to hire for Weddings, Birthday Parties, seminars, corporate or other special occasions.

Annual Membership Types and Fees

- **Full member \$505** - Entitles the member to full use of Club facilities and voting rights.
- **Country Member \$255** - Applies if you live more than 100km from the Club premises. Full use of the Club facilities but no voting rights.
- **Associate / Social Membership \$130** - For those who wish to use the Club's social facilities - Associate members are not permitted to bring or launch a boat and have no voting rights but may enjoy all the other amenities of the Club.

Annual membership fees are pro-rata based on when you join - July to September 100%, October to December 75%, January to March 50% and April to June 25%.

Nomination Fee

All full membership applications must be accompanied by a nomination fee of \$505 (Inc. GST) and must be Nominated and Seconded by Full Financial or Life members or the General Manager. Please contact our Office if you require assistance with this requirement.

Ancillary Fee

An ancillary fee of \$94 is required from all new members to cover an ice key, remote access air key and a Club burgee.
